### **Notice for Public Comment Magisterial District Reestablishment Plan**

Pursuant to the Pennsylvania Constitution, a reestablishment of Magisterial Districts is to occur in the year following the Federal Decennial Census. As such, each Magisterial District within Lawrence County has been analyzed and evaluated with respect to population, caseload, and workload measures. As a result of this analysis a recommendation is planned to be submitted to Pennsylvania Supreme Court that Magisterial Districts 53-1-01, 53-3-1, 53-3-02 and 53-3-04 be reestablished as they currently exist within Lawrence County.

Interested parties may view the plan between January 19, 2022 through February 16, 2022 during work hours of Monday through Friday from 8:00 a.m to 4:00 p.m. at the Lawrence County Government Center, 430 Court Street, New Castle, Pa 16101 in the Court Administration Department and Lawrence County Law Library located on the 3rd Floor of the Government Center.
